# NewLook International, Inc. Mean Klean™

## Technical Information Sheet

NewLook Mean Klean™ is a liquid chemical that dissolves concrete and mortar for easier cleaning. It is the eco-friendly, non-fuming alternative to harsh cleaning acids or hazardous etching chemicals. The advanced liquid formula dissolves and physically breaks down concrete by attacking the Portland cement and other unique chemical properties, reducing it to a mush that's easy to clean and remove from the surface.

### USES AND BENEFITS

- Use Mean Klean to safely clean, dissolve and remove concrete, cured cement, mortar, grout and stucco.
- Use to clean trowels, screeds, hand tools, mixers, pumps, scaffolds, mud tubs, mud boards, trucks, trailers and silos, saws, drills, generators, augers and more.
- May be used to etch concrete and open the surface pores in preparation for decorative coatings.

### APPLICATION PREREQUISITES

- Mean Klean is water-neutralized. Never wet surface with water before applying Mean Klean
- Protect walls and adjacent areas where dissolving is not desired
- DO NOT dilute Mean Klean.

### APPLICATION OF MEAN KLEAN

1. Mean Klean is intended to be used as provided and NOT diluted.
2. Apply with a NewLook Applicator Brush™ or Sprayer. Some tools may be soaked in trays.
3. Completely saturate concrete with Mean Klean. Surface will turn white, then darken. White residue may appear if Mean Klean evaporates.
4. Do not rinse. RE-apply to reactivate as needed until concrete has softened and dissolved.
5. Allow Mean Klean to penetrate 10-15 minutes. Keep surface saturated.
6. Concrete will soften and release from surface after approximately 20-30 minutes. Needed soak time depends on the thickness of material being removed.

7. Rinse with cold water. Use a garden hose with nozzle or pressure washer.
8. Repeat as needed.
9. Mean Klean will not harm paint, metal or wood. Only Portland Cement.
10. Mean Klean may also be used for concrete etching. Apply with a wand sprayer evenly. When etch time has completed, neutralize with water. A mop may be necessary to clean up the residue.

### STORAGE

- Store in original container in areas inaccessible to children and pets.
- Keep containers tightly sealed.
- Do not reuse empty container. Rinse empty container and replace cap before discarding.
- DO NOT allow product to freeze.

### LIMITATIONS

- Any water on the material will neutralize the effects of Mean Klean and it will no longer be effective.
- Avoid prolonged contact with concrete surfaces that should not be dissolved.

### CAUTION

KEEP AWAY FROM CHILDREN AND ANIMALS. Before using or handling, read the MSDS and Product Instructions. DO NOT CONSUME. Avoid contact with eyes and skin. Wear rubber gloves, aprons and safety eye goggles. Use good hygiene when handling this product. It is recommended that you wash and bathe after each use.
