## RECOMMENDED USAGE

#### PRODUCT DATA

- Appearance: White Granular.
- Density: 25-31 lbs/cubic food.
- One 2.5 oz. bag will harden up to a ½ gallon of left-over stain.
- One 30 lb. pail will harden approximately 95 gallons.

## **DIRECTIONS FOR USE**

- Add the crystals to the waste or spilled liquid. One cup of water may be added to thick paint for ease-of-use.
- 2. Stir mixture until thick.
- 3. Scrape spills into a pile.
- 4. Dispose of as regular garbage in accordance with local regulations.
